Dear Camper,

Golf cart ownership has increased in the past few years. In response to this growing trend, we have had to establish guidelines for operation of golf carts and unregistered motorized vehicles. As with any vehicle, certain guidelines need to be in place to insure the safety of our guests as well as safety of the operator.

Golf carts and unregistered motorized vehicles operated on Lone Oak Campsites property, are required to have personal liability insurance coverage. **A copy of the certificate of liability insurance will be required to operate a golf cart or unregistered motor vehicle.** The copy should be mailed to the office before the start of each season.

We ask that you register your golf cart/unregistered motor vehicle and the household members who will operate the golf cart. Keep in mind the permissible operators must possess a valid drivers license.

You will be issued an operating sticker to be placed on your golf cart upon return of a completed golf cart registration form. The sticker should be placed in the center front of the golf cart.

For proper identification, we are asking for all golf carts and unregistered motor vehicles to be identified with their owners name and site number. The letters/numbers should be at least 2 inches high or larger and placed in a location that is visible at all times on the golf cart.

Golf Cart Use Policy at Lone Oak Campsites

1. Operators must hold a valid drivers license.
2. No unnecessary use after quiet hours
3. Motorized vehicles must not be operated under the influence of drugs or alcohol.
4. Speed limits must be followed for the safety of pedestrians.
5. Golf carts used during the night must have working headlights and taillights.
6. Never leave the keys in the golf cart, and never leave the golf cart in gear.
7. There must not be more people riding in a golf cart, than actual seating capacity allows for.
8. Golf cart/motorized vehicle must have proper muffler so as not to disturb other campers.
9. Golf carts must be registered with the office, as well as permissible operators, at the beginning of each camping season.
10. Lone Oak campsites requires verification of personal liability insurance (a Certificate of Liability) from the golf cart owner each season.
11. We do not allow the use of ATV's, mini-bikes, go carts, dirt bikes, or scooters in the campground.

These policies supersede any previous golf cart policy or agreements.

In summary;

- Please complete, sign and return the Golf Cart Registration Form before you are to operate your cart. See reverse for the Golf Cart Registration Form.
- **A completed registration form includes a copy of a valid insurance policy stating your golf cart is covered for use at Lone Oak Campsites.**
- Golf carts will not be allowed to be operated until all the paperwork is filled out and filed with the office.
- Identify your golf cart with owners name and site # with 2 inch letters
